

AN ORDINANCE TO AMEND TITLE 8, CHAPTER 2 OF THE COLUMBIA MUNICIPAL CODE BY DELETING SECTION 8-203 IN ITS ENTIRETY AND REPLACING SAID SECTION WITH A NEW SECTION 8-203 AND BY DELETING SECTION 8-222(3) AND REPLACING SAID SECTION WITH A NEW SECTION 8-222(3) CONCERNING THE HOURS OF SALE OF BEER AND THE DEFINITION OF BEER

WHEREAS, the City of Columbia regulates the sale of beer within the corporate limits of the City of Columbia; and

WHEREAS, the City Council of the City of Columbia wishes to amend the provisions relating to the hours of sale of beer as well as the definition of beer to comply with changes in the state law.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF COLUMBIA, as follows:

Section 1. That Title 8, Chapter 2, Section 203 of the Columbia Municipal Code is hereby amended by deleting said section in its entirety and replacing said section with a new Section 8-203 as follows:

8-203 – Beer Defined.

The term “Beer” as used in this chapter shall mean and include all beers, ales, other malt beverages, or any other beverages having an alcoholic content of not more than the specified percentage set by the State of Tennessee, which at the time of enactment of this Ordinance is not more than eight percent (8%) by weight, with the exception of wine as defined in Tennessee Code Annotated Section 57-3-101.

Section 2. Be it further Ordained that Title 8, Chapter 2, Section 8-222(3) is hereby deleted and replaced with the following:


8-222 – Prohibited Conduct or Activities by Beer Permit Holder.

(3) Make or allow any sale of beer or intoxicating liquor, or make, cause or allow to be made any gift thereof, between the hours of Three o'clock a.m. (3:00 a.m.) and Eight o'clock a.m. (8:00 a.m.) during any night of the week except on Sunday and between the hours of Three o'clock a.m. (3:00 a.m.) and Ten o'clock a.m. (10:00 a.m.) on Sunday. With the exception of

Sunday the sale of package beer shall be allowed daily after Eight o'clock a.m. (8:00 a.m.). On Sunday, the sale of package beer shall be allowed after Ten o'clock a.m. (10:00 a.m.)

Section 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.
